
General Safety Instructions

- Safety first! Do not perform any work if you are not absolutely sure how to work safely.
- The fundamental rule applicable to all work conducted at Hauff-Technik is: no briefing no work! Briefings shall be conducted before the start of work.
- Obey all instructions of your Hauff-Technik contact person and report safety related defetcs to your Hauff-Technik contact person or to your reporting manager.
- Always work cautiously and ask questions if anything is unclear.
- Report any damage to the safety infratructure and accidents immediately to your reporting manager or your Hauff-Technik contact person.

Traffic rules

- Stay on the marked pedestiran routes.
- Forklifts have right of way! Walk cautiously in traffic areas.
- High-visibility vests are required in outdoor areas outside the marked footpaths and in the logistics center.
- Wear safety shoes in all areas outside the marked pedestrian routes and office buildings.

First Aid / Fire protection / Escape routes and emergency exists





 Be aware of the location of the next fire extinguisher/first aid-box, the escape route in case of an emergency and how to inform the first responders for fire safety and/or first aid?



- Make sure to enter all injuries in the firt aid book.
- In the event of a fire alarm, leave the building immediately and go to one of the marked assembly points. Wait there for further instructions.
- Always keep traffic, escape and rescue routes as well as emergency exits clear.

Safety equipment

- Always use the safety equipment which is required for the specific workplace.
- Do not use faulty safety equipment. Check your equipment for noticeable defects before use.

Safety signs and other information

• **Mandatory signs:** Round and blue – signalling an obligation to do something



- Prohibitory signs: Round and red signalling prohibition
- Warning signs: Attention, Risk, Danger! warning of hazards



- Consumption of alcohol is strictly prohibitted
- Smoking is only permitted in the indicated smoking booths and only for persons, <u>above 18 years of</u> age.
